Dear Members,

It's been a busy and satisfying time and I wish to share important news and updates about your Club. We are pleased to inform all members that the Lease for the Club has been extended by the Government until 2050. Our grateful thanks to Shri Kamal Nath, the Hon'ble Minister for Urban Development for his foresight and vision to see this Club as one of the best in Asia, if not the world.

As you are all aware, an EGM was held on 28th of June and resolutions for amendment of Articles relating to extension of the lease were put up to and, approved by the members of the Club.

Meanwhile, the new building plans are under consideration by the General Committee and once approved, the same will be placed before the members of the Club for their consideration.

The status of renovation and works to improve Club facilities is included in the Chairmen's Reports, and I'm sure the members will be pleased with the progress. Course facilities are also being addressed:

- The laying of the cart path on the 9th Hole has been completed.

This will allow senior members to play when the course is wet and also save the turf. Members are requested not to take the cart on to the fairway when it is wet.

- The course is playing well considering the intense summer and we appreciate the efforts of the Course Staff. There is some problem in the bunkers because of the non-availability of the required sand which we are trying to procure.

- We are planning on re-doing the chipping area. The design has been forwarded by our Golf Architect, Mr. Phil Ryan, and once the Greens Committee approves this, work will begin.



- Permission has been sought from the Department of Forests, Delhi Government, to develop the Peacock Course. The President and I met the Hon'ble Chief Minister and we are fairly positive approval is forthcoming. Once we receive this, we shall bring it to the

members for their views and inputs.

In other news, the Code of Conduct for the Club Elections has been approved by the General Committee and is posted on the Notice Board and placed on the Club's website www.delhigolfclub.org. The new Members' Directory, sponsored by Golf Digest India, is being prepared and hopefully this should be released during the Club Nite before the Club Elections.

I wish to introduce Mr. Amit Deb who has joined the Club as Deputy Secretary on 6th August 2012; Mr. Anunay Srivastava, Manager Accounts, who is replacing Mr. Inderjit Sharma who is retiring after 20 years with the Club and, Mr. Arvind Prakash who joined as General Manager, F&B from 13th August 2012. They come in to strengthen the Executive staff and improve the quality of service to members both within the Secretariat, as well as in the F&B outlets.

Throughout this summer the course has played far better than in previous years, and is looking healthier due to better maintenance practices. Cart paths have been laid on the back nine to facilitate carts being used during the monsoon months. Senior members who are dependant on carts should continue to enjoy their game uninterrupted; closure of the course will be kept to a minimum. Members are requested to keep the carts on the cart paths so that damage to the turf is minimal, especially when the fairways are wet.

We are also looking to upgrade the chipping area to international standards. Extensive discussions are underway with Phil Ryan who will shortly be giving us a revised plan; we hope to execute this during the remaining months of this year. We have also applied for and are hopeful of receiving permission to enable the crucial removal of a few trees so that the up-gradation work of the Peacock Course may commence. This Committee hopes to put everything in place so that the incoming Committee may execute the work, after presenting the same to the members.

We would like to inform you that the statutory audit for the year ended 31st March, 2012 is in progress and no major anomaly has been found by the auditors. As per the draft income expenditure account we shall close the year with the surplus. With better investments and stricter controls we have managed to achieve a surplus even after spending on all the projects recommended by the various Sub-Committee that too without increasing Subscription etc., and without burdening the members. Our cash reserve position has improved.

TECHNOLOGY

To facilitate control in F&B, we had recommended to the General Committee the implementation of the rule that makes it compulsory for members to produce their Swipe Card before placing an order. The General Committee has approved the same and this will be implemented w.e.f. 1st September, 2012. It will have numerous advantages and a detailed circular has been sent to members.

We are also in the process of developing an Assets Life Cycle Management Programme which will be helpful in the follow-up of a Regular Maintenance Servicing & Replacement Schedule of all the Club's equipment and course machinery.

The Club has started the process to customize an Electronic Document Management System by digitizing and microfilming all documents and records of the Club. This will assist in the storage, as well as retrieval, all paper records instantaneously.

The Club is in the process of posting the status of up-gradation of 'C' to 'B' and 'B' to 'A' membership on the website.

PURCHASE

Significantly, despite high inflation in the cost of all food items and steep increases in the prices of many other products, we were able to finalize the annual rate contract with a marginal increase of only 5.9%. The Finance Department worked hard to enroll new suppliers, thus creating competition to get the best prices.

The second thing of note is that the important project of the renovation of the kitchen is in its final stage. Members would be happy to note that the brand new state of the art kitchen will be operational shortly.
